"Partnering Municipal Councils, Westlake Watershed District Board, Provincial and Watershed Staff have spent hundreds of thousands of dollars, massive amounts of inkind volunteer and paid resources and many years in pursuit of an Order in Council (Now Regulation Map) that accurately reflects Westlake Watershed District's Infrastructure responsibilities.

The original Order in Council Map contained errors that District Staff had repeatedly asked (in writing) to be corrected since at least 1985. The Province has failed to address those errors even to this day - 32 years later.

The Order in Council Map (File Number 82-1-1178) was revised on January 14, 1999 when Lawrence (now RM of Lakeshore) joined Alonsa Conservation District (Now Westlake Watershed). At that time the errors going back 14 years to 1985 were not corrected by the Province. The Order in Council Map that was drafted in 1999 to include Lawrence in the Alonsa Conservation District used Water Resources Branch Map "Hamelin Drain and Adjacent Area Map (file# 84-1-1009 Watershed, 107). The Province knew during this time that file #84-1-1009 contained inaccurate data as 2 DES areas as they had been left out of an earlier mapping process. These areas (DES 105 & 107) have not been completed to this day. Regardless the province proceeded to incorporate known inaccurate data into the "new" expanded Order in Council Map further decreasing the document's accuracy during this expansion.

The District Order in Council /Regulation Map is the core document used to operate this Watershed as required by the Province of Manitoba. The Province of Manitoba has knowingly allowed this issue to persist for 42 years and even required that inaccurate data is used. The cumulative results of inaccurate spatial data being used over the past 42 years is difficult to quantify - however there are a few issues caused by these inaccuracies that highlight the importance of this issue all on their own:

1. Rorketon Lagoon was licensed by the Province to discharge into an illegal drain. A short time later the Province actually ordered that drain closed. Had all parties been working with accurate data this would not have happened. The situation exists to this day and the Province has not been willing to acknowledge or take responsibility for this error, even after it was brought forward before the Municipal Appeal Board in 2015.

2. Confusion among the public is common when clients view the OIC map. It is used daily and in all of our media to communicate with the public as to what District responsibilities are. This inaccuracy causes discord and has resulted in illegal works performed by well meaning stakeholders and degraded public perception of The District, The Conservation/Watersheds Programs and the Province of Manitoba. Obviously given the first point above the situation highlights the level of confusion caused even within the Province and it's licensing and regulatory bodies.

3. The Watershed Districts entire budget and planning (down to daily operations) depends on this map and it's level of accuracy. An accurate map would increase efficiencies for the entire watershed directly proportional to the number of corrections made. In this case planning and budgeting efficiency could be increased by 10-14% annually with accurate map data. Further efficiencies concerning planning and operations at Manitoba Infrastructure and Partner Municipalities would result as well.

4. Confusion in the general public has resulted in civic unrest between land owners, Indigenous communities, Municipalities and the Watershed District. The District has maintained files of all communications on this mapping issue since establishment of the District in 1978. The Province is culpable in a range of issues resulting from an unwillingness or technical incapacity to manage and correct this map data. 5. The Watershed District has technical capability and local knowledge superior to what Planning and Programming Section can offer. According to Planning and Programs Watershed, organizations are not allowed to generate Provincial Data for use in the Regulation Map. Even so District Staff have been ordered on numerous occasions, using various methods to provide said data to the Province - only to have it disregarded and filed away by Planning and Programs.

6. In certain instances District staff are asked or ordered to produce spatial and mapping data to resolve issues the Province views as priority but are unrelated to our Regulation/OIC map. In these instances, the Province readily accepts the data and designs solutions based on the provided data. This is a double standard. The Province needs to address this by increasing their own technical capacity to support their own staff or formalizing requirements and standardizing how our Districts provide data back to the Province.

7. Meetings have been held in every community in the Watershed so that Planning and Programs Section could consult on the mapping issue. Many consultation meetings have been called by Planning and Programs in Dauphin, Portage and Winnipeg regarding the mapping issue. There has been no significant corrective action taken as a result and District Staff and Board Members have been criticized by Planning and Programs Section for budget sections with deficits directly caused by the many meetings and their inability to properly manage the information provided to them.

8. Planning and Programs Section have advised the District last minute in the Regulation Map Generation Process that in order for changes to be made to the regulation map, all Municipal Partners are to provide resolutions on each change. Given the fact that the Municipalities appoint all members of the Watershed District Board the assumption was made that the duty to consult had been met. Even still had the District been made aware that resolutions were needed earlier in the map revision process respective councils (knowing the implications of inaccurate data after a 42 year struggle to have it corrected) would have been enthusiastic in trying to resolve this issue and provided resolution quickly.

9. One reason the Watershed Board believed we had met the duty to consult is the fact that Planning and Programs took it upon themselves to correct some of the inaccurate data by removing drains from the map even without approval from the Municipalities. It seems that despite the fact that these drains had never even been ground truthed by Planning and Programs Staff in several instances they circumvented their own consultation processes to make these changes.

10. Most of the infrastructure mandated to the Watershed District to maintain (including ex-Provincial Infrastructure off loaded to the District) does not include any caveat or right of access. This places District Staff, Councils and Board Members in a bad legal position. In order to perform our mandate we are actually required by the Province to break their own trespassing laws. Worse yet we are required to use heavy machinery on these drains to maintain them. If a workplace safety situations results in injury or death we are effectively breaking the law performing that work and could be subject to legal actions with unknown consequences. If a client/stakeholder sees an accurate map that designates responsibility of infrastructure to the District there is more willingness to allow our mandated activities to continue and avoid legal implications arising from trespassing.

Therefore be it resolved that the Province immediately undertake executive action to compel Planning and Programs Section to correct the known data inaccuracies and provide a single document outlying the process used to address future data deficiencies. This document should also offer a legal perspective in regards to implications of a mandate to maintain infrastructure where no access arrangements have been made. It should include perspectives from Manitoba Workplace Health and Safety, the Association of Manitoba Municipalities, Manitoba Surveyors, Environmental Law Specialists and any other perspective seen as important.

Be it further resolved that the Province examine and restructure the manner in which Planning and Programs Section engages The Municipalities, The Districts and The Province. This organizational review should be completed by an outside consultant, address the capacities of all parties as they relate to resource management and offer advice as to how the program should move forward based on the new boundaries and regulations of the past 2 years. As part of this review special consideration should be given as to the level of local authority a Watershed District needs to operate efficiently while allowing the Province to retain regulatory oversight."
