The Rural Municipality of Lakeshore would like to work Co-operatively with the Province – Planning and Program staff to address these issues prior to finalizing the New Regulation Map.

7.1 Regulation Map for Westlake Watershed District Includes Weiden Drain

Whereas: the Rural Municipality of Lakeshore is a member of the newly formed Westlake Watershed District, formerly known as the Alonsa Conservation District;

and

Whereas: the order in Council maps will now be replaced by Regulation Maps under the authority of the Watershed District Act and these Regulation Maps will identify Watershed District Drains based on updates provided for this review; and Whereas: the Council of the Rural Municipality of Lakeshore, along with the Westlake Watershed District have spent considerable time and resources to update these maps with Planning and Programming Section, however, no significant corrective action has been taken despite our local input; and

Whereas: numerous issues within the development of the old Order in Council Map have not been addressed in the development of the New Regulation Map (Letter Attached)

Therefore: Be it resolved that the RM of Lakeshore urge the Province and Planning and Programs Division to re-examine the proposed Regulation Map to reflect the input brought forward to address these issues as well as including the Weiden Drain in it's entirety prior to finalizing the New Regulation Map.

It has been determined that services should be prioritized as follows:

- 1. Water and Sewer Services Must Operate
- 2. Fire Service Must Operate
- 3. Public Works Must Operate (Possible Modifications)
- 4. Council and Management Staff Must Operate (Possible Modifications)
- 5. Office Staff Operate (Possible Modifications)
- 6. Recreation Facilities **Closed Until Further Notice** (Community Centers, Resource Center, Library, etc.)

Water and Sewer Services and Fire Protection Services are priority for the operation of our Municipality. Therefore, these resources will operate for continued service.

Services not related to water, sewer, or fire, may be limited at times, or temporarily suspended according to the required response.

Council and Staff for the Rural Municipality of Lakeshore appreciate your cooperation and understanding as the situation develops, which may, or may not have an effect on our ability to provide full operational services. Essential Services will not be interrupted unnecessarily. We are depending on the expertise of Provincial Public Health to provide guidance on the matter to respond and maintain safety in our communities.
