Steenkamp Drainage Request Update Works Completed: -Blading roads & repairing frost boils -Grass has all been gone over at least once waiting to receive confirmation to cut some private, unsightly lots in Ochre -Significant landfill clean up. Garbage coverage, e-waste hauled, paint hauled, garbage picked -Began digging shale from beside River -Tucker's have graveled Ward 5 and have moved onto ward 6 -Beaches were bladed and speed bumps have started to be installed hopeful to finish installation this week -Started stock piling shale at Sametz property -Started prepping Shulte for ditch cutting -Some spot gravelling done with tandem on old highway -Stones dug out of Park hoping to get soil from the Turtle Cemetery project to fill this week -1 of 2 quotes attached for landfill cages The two Public Works Green Team employees that Ryan and Peter decided on were available to start on June 22, 2020 so they started Monday.

11.7 Support of Improvements to PR 366 Resolution No: 2020-169 Moved By: Mike Brunen Seconded By: Richard Kachur

Whereas Provincial Road 366 (PR 366) starts in the Swan River Valley region of Manitoba, serving Bowsman and Minitonas, crosses the Duck Mountains, and goes through West-central Manitoba from Grandview to Inglis; And whereas PR 366 serves as the main North-South route through Duck Mountain Provincial Park;

And whereas it is mainly a gravel route, 219 km in length; And whereas Grandview has been best known as the "Gateway to the Ducks";

And whereas the Duck Mountains form a segment of Manitoba's escarpment and are becoming more and more popular, with spring-feed lakes along almost the entire stretch of PR 366;

And whereas there is great opportunity to explore some of nature's best offerings; fishing, bird watching, Duck Mountain Interpretive Centre, hiking trails (10 km), picnicking, Baldy

Mountain (Manitoba's highest peak);

And whereas PR 366 has extremely poor road conditions which can lead to accidents injuring drivers, passengers, and pedestrians;

Therefore be it resolved that Council for the RM of Lakeshore support the Grandview Municipality in lobbying the Manitoba Provincial Government to improve the road conditions of PR 366.
